By enrolling my child and signing this document, I agree to and understand the following:

Hidden Pond Day Camp, is accredited by the American Camp Association, is licensed by the New York State Department of Health, and is inspected yearly. Copies of the inspection are kept on file in the County Health Department Office.

This contract is not valid unless signed by enrolled camper's parent or guardian (the "signor") and accepted by the Camp Director. The signor agrees to pay the tuition as per the published schedule for the enrollment period. In the event this contract is executed by one parent, the signor acknowledges that he/she is also acting as an agent of the other parent with authority to enroll the child at camp and to execute this contract on his or her behalf.

Tuition includes: 1 tee-shirt, camp bag, daily lunch, daily snack, and use of all athletic equipment.

A non-refundable Deposit of \$200 is required at the time of sign up.

A second installment of \$500 per child will be due by Feb. 9, 2010.

Anyone signing up after 2/10/10 is expected to submit a deposit of \$700 (\$200 non-refundable deposit + the first payment of \$500)

Anyone signing up after the final payment date is expected to pay in full at the time of sign up.

Deposits and payments are only transferable to children within the same nuclear family.

The Balance of tuition is due April 27, 2010. Hidden Pond reserves the right to cancel the child's registration if full payment is not received by April 27.

P.M. Extended:

If a child is not picked up during dismissal, he/she will be placed in our PM Extended Program. Payment for the PM Extended program is due in advance or at the time such services are rendered. For fee schedule, please see the front page of this application

By enrolling my child, I hereby grant permission:

1. To photograph and video my child during Camp Activities and to allow Hidden Pond Day Camp to utilize such photography and or video for promotional purposes.
2. To participate in any camp sponsored trips during their enrollment period.
3. To participate in all programs that are arranged and supervised by Hidden Pond Day Camp Staff.

Waiver and Release of Liability:

In consideration of my child being allowed to participate in any way in HPP Rinx Inc. d/b/a/ The Rinx, and HPP Summer Camp Inc., athletic/ sports events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. There is a possible risk of injury from activities involved in this program and while particular rules and personal discipline may reduce the risk, the risk of injury does exist.
2. I knowingly and fully assume any and all such risks which are inherent in the activities in which I or my child are engaged, both known and unknown, for myself and my child, even if arising out of the negligence of the releasees and am participating or allowing my child to participate in all activities voluntarily and am willfully undertaking and assuming all such risks.
3. I willingly agree to have my child comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove my child from participation and bring such to the attention of the nearest camp official immediately; and
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the Town of Islip, HPP Rinx Inc., and HPP Summer Camp, their officers, officials, agents and / or employees, and other participants, ("releasees"), with respect to any and all injury, disability, death or loss or damage to person or property whether arising from the negligence of the releasees or otherwise.

I/we have read this release of liability and fully understand its terms. I/we further understand that there are certain risks inherent in the activities engaged in and I/we assume said risks. I/we have given up substantial rights by signing this release and sign it voluntarily and free for coercion. Should any portion of this agreement be determined unlawful, all other portions shall remain in full force and effect.

All "Refund Requests" must be made promptly, in writing, and in accordance with our refund policy.

For the general welfare of all campers, the Camp reserves the unrestricted right to dismiss any camper whose conduct or influence, in the opinion of the director, is contrary to the best interest of the campers and the camp.

Permission to provide Emergency Care:

In the event I cannot be reached in an emergency, I hereby give permission to the physician selected by the camp director to secure and administer all necessary treatment, including hospitalization and emergency diagnostic treatment for my child enrolled at Hidden Pond Day Camp (HPP Summer Camp, Inc.). I also give permission to release any records necessary for insurance purposes; and to provide or arrange necessary emergency related transportation for me/ or my child. This completed form may be photocopied for a trip out of camp.

This contract constitutes the full understanding of the parties hereto and no change, modification or waiver of any of the terms shall be effective unless in writing and signed by both parties.

Hidden Pond Day Camp at The Rinx Cancellation/Refund Policy

1. All Payments, less a non-refundable deposit/administration fee of \$200 shall be refundable until April 27.
2. If a child, prior to the commencement of his/her enrollment period, is unable to attend camp because of an appropriately documented illness or injury, all monies will be refunded less the \$200 non-refundable deposit/administration fee.
3. No refund will be made for late arrivals, early departures, or dismissal for cause. Tuition and fees are agreed to be the reasonable amount as and for liquidated damages.
4. If tuition is not paid as per the schedule of payments set forth on this application, early enrollment credits and or discounts will not adhere and enrollment may be cancelled and no refund made.
5. There will be no refunds or make-up days for non-consecutive missed days of camp due to illness, family matters, homesickness, or injury. If a camper is absent consecutively for three days or more, due to medical reasons only, a refund, or credit towards an additional week or next years enrollment will be made for each day missed, provided a physician's note is submitted appropriately evidencing medical reasons for the absences.
6. Due to camper security no make up days will be permitted.
7. All "Refund Requests" must be made promptly and in writing.

If you wish to add weeks to your enrollment at a later date, the cost will be calculated based on the Existing Enrollment Rates at the time of your extension.
